

Response to Local Offer Questions

When the Children and Families Bill becomes enacted in 2014 local authorities will be required to publish and keep under review information from services that expect to be available for children and young people with SEND aged 0-25. The intention of this local offer is to improve choice and transparency for families. From the Local Offer parents and carers will know what they can reasonably expect from their local area. It will also be an important resource for professionals in understanding the range of services and provision in the local area. This information will be web based and there is an expectation that all providers will need to answer the 14 questions (as referenced to in this document). We have added prompts as guidance but there may be more information that you would like to add about your setting.

Progress closely monitored by SENCO and SSP updated every 6-8 weeks. • Enhanced Ratio sessions/focused sessions, as set out in SSP, are carried out by child's key person or other specialist staff, supported and monitored by SENCO. • Early Intervention Funding (EIF) and Education Health and Care Plan (EHCP) applied for where applicable. • Referrals to outside agencies e.g. Speech and language are made where appropriate. • Regular meeting with parents. Team around the family meetings where outside agencies are involved. • On transition we work closely with other settings and schools whether the child is joining or leaving us.

How will that help my child/young person?</p>	<p>Planning for individual children and stages of development and environ, IEPs, additional support</p>	<p>West Byfleet Nursery follows the Early Years Foundation Stage 2025 in the following ways:</p> <ul style="list-style-type: none"> • Supporting each child's individual needs. • Activities are adapted to each child's level of learning and development enabling them to progress to their next stage. • Any child with additional needs will be supported through small group work and 1:1 sessions as set out in their SSP. • Making reasonable adjustments to the environment • Follow child led interests to scaffold and extend their learning.

<p>4) How will both you and I know how my child/young person is doing and how will you help me to support my child's/young person's learning?</p> <p>In addition to the normal reporting arrangements what opportunities will there be for me to discuss his or her progress with the staff? How does the setting / school / college know how well my child/young person is doing? How will I know what progress my child/young person should be making? What opportunities will there be for regular contact about things that have happened at early years setting / school / college eg a home school book? How will you explain to me how his or her learning is planned and how I can help support this outside of the setting / school / college? Do you offer any parent training or learning events?</p>	<p>Meetings with parents, use of learning journey and summative assessment, 2 year progress check, COP and IEPs</p>	<p>West Byfleet Nursery staff supports parents/carers and keeps them informed of their child's progress in the following ways:</p> <ul style="list-style-type: none"> • Daily verbal feedback at drop-off and pick-up times. • Open door policy for Key person appointments. • Monitoring your child's achievements and progress and highlighting any areas requiring additional support. • Parents access to Tapestry online learning journey. • Parent's evening twice a year where we share your child's achievements, progress and next steps. • Additional consultations and progress reviews on request. • Meeting to review two-year progress check. • Consultation on and review of SSPs. • Provide information on activities to share with your child at home and at other venues e.g. Local family centres.
<p>5) What support will there be for my child's/young person's overall well-being?</p> <p>What is the pastoral, medical and social support available in the setting / school / college for children with SEND? How does the setting / school / college manage the administration of medicines and providing personal care? What support is there for behaviour, avoiding exclusions and increasing attendance? How will my child/young person being able to contribute his or her views? How will the setting / school / college support my child / young person to do this?</p>	<p>Administering medicines policy and care plans. Consulting with children, behaviour management and policies. Surrey's guidance on intimate care and toileting</p>	<p>West Byfleet Nursery aims to support all children with their pastoral, medical and social needs without exception. Our staff will support children's well-being in the following ways:</p> <ul style="list-style-type: none"> • Administer prescribed medicines with parent/carers written permission. • Staff are first aid and EpiPen trained. Further training will be undertaken as required. • Implement care plans based on individual needs. • Adapt environment and routines, where possible. • Trained staff will implement individual improvement plans to support a child's behaviour management needs. • Work with parents with intimate care and toilet training unless there are any medical or developmental reasons why this would be inappropriate. • Respecting any cultural or religious sensitivities regarding toileting, intimate and personal care.

<p>6) What specialist services and expertise are available at or accessed by the setting / school / college?</p> <p>Are there specialist staff working at the setting / school / college and what are their qualifications? <p>7) What training are the staff supporting children and young people with SEND had or are having?</p> <p>This should include recent and future planned training and disability awareness.</p>	<p>Staff training and qualifications e.g. SENCO COP, Makaton, ELKLAN, INSET, SENCO forums</p>	<p>West Byfleet Nursery aims to support children with SEND by providing staff who are highly qualified and:</p> <ul style="list-style-type: none"> • Attend SENCO networks and SCC SEND surgeries. • Attend SEND COP training updates. • Attend all relevant training update sessions and INSET days. • Are aware of all relevant legislative changes and related policy and procedural updates. • Work closely with the SENCO who will offer support and strategies.

<p>8) How will my child/young person be included in activities outside the classroom including school trips?</p> <p>Will he or she be able to access all of the activities of the setting / school / college and how will you assist him or her to do so? How do you involve parent carers in planning activities and trips?</p>	<p>Planning for trips out to include all children, adaptations and additional support</p>	<p>West Byfleet Nursery supports children of all abilities to access activities outside the classroom in the following ways:</p> <ul style="list-style-type: none"> • All activities take place within the nursery/ infant school grounds. • Detailed risk assessments. • Excellent staff to child ratios at all times. • Close staff supervision on all outdoor play equipment including slides, climbing frames, bikes, and scooters. • Provision of a wide range of outdoor activities including musical fun, painting, sand and water play, mud kitchen, messy play, outdoor maths, and gardening. • All activities modified to meet child's level of development.
<p>9) How accessible is the setting / school / college environment?</p> <p>Is the building fully wheelchair accessible? Have there been improvements in the auditory and visual environment? Are there disabled changing and toilet facilities? How does the setting /school / college communicate with parent carers whose first language is not English? How will equipment and facilities to support children and young people with special educational needs be secured?</p>	<p>Current and possible changes to your premises, including all families, translations, visual support, extra funding (Inclusion grant etc) Equality Act, making reasonable adjustments</p>	<p>West Byfleet Nursery supports children of all abilities to access the setting in the following ways:</p> <ul style="list-style-type: none"> • Single storey building with wheelchair access and disabled toilet facilities. • Provision of translation of documentation to EAL (English as an Additional Language) families, on request. • Refer children with EAL to REMA (Race and Ethnic Minority Achievement Service). • Applying for funding grants for additional equipment. • Making reasonable adjustments to the environment.

<p>10)How will the setting /school / college prepare and support my child/young person to join the setting /school / college, transfer to a new setting / school / college or the next stage of education and life?</p> <p>What preparation will there be for both the setting / school / college and my child/young person before he or she joins the setting / school / college. How will he or she be prepared to move onto the next stage? What information will be provided to his or her new setting / school / college? How will you support a new setting / school / college to prepare for my child/young person?</p>	<p>Transition meetings and links with other settings and schools, TAC and multi disciplinary meetings to prepare for a child. Photo books and visits, Info passed on to new setting, Learning journeys, assessments etc</p>	<p>West Byfleet Nursery aims to promote the accessibility of our nursery to children and families from all sectors of the local community. The setting prepares and supports children of all abilities for transitions in the following way:</p> <ul style="list-style-type: none"> • Parents/carers and children will be given the opportunity to attend an out of hours drop-in induction session before they start at the nursery. • Practitioners will work with the child and parents/carers using different strategies during the settling in period to establish the best way forward for the child. • For transition to a new school/setting, practitioners will attend any meetings arranged by the new school. • Staff from the new school/setting will be invited to visit and meet the child and their key person in our setting. • Transition reports are written and sent to the new school/setting. • Online learning journeys are available to download by parents, which they may then share with the new school/setting. • Role Play activities involving moving on are included in the classroom activities. • Photo books using pictures of old and new settings and staff are created where appropriate.
<p>11)How are the setting`s/school`s/college`s resources allocated and matched to children`s/young people`s special educational needs?</p> <p>How is the setting's / school's / college's special educational needs budget allocated?</p>	<p>Deployment of staff in setting, additional funding e.g. Inclusion grant, discretionary funding, EHC Plan</p>	<p>West Byfleet Nursery does not have a specific SEND budget however</p> <ul style="list-style-type: none"> • additional funding can be applied for in the form of EIF and EHCP. • additional resources will be sourced if required to ensure each child is supported and their well-being managed. • where deemed appropriate for the child's needs, we will provide enhanced ratio or small group support.

<p>12)How is the decision made about what type and how much support my child/young person will receive?</p> <p>Describe the decision making process. Who will make the decision and on what basis? Who else will be involved? How will I be involved? How does the setting / school / college judge whether the support has had an impact?</p>	<p>Meetings with families and all professionals involved with child, EHCP, allocation of enhanced ratio support</p>	<p>At West Byfleet Nursery decisions regarding the type and how much support a child will receive are made by the setting on an individual basis, in consultation with all involved outside agencies/professionals and parents/carers subject to the availability of funding and other resources. The child's progress is reviewed every 6-8 weeks, targets updated, and information is shared with parents/carers and all involved professionals. If felt necessary the setting will collect evidence and start the process of applying for an Education, Health and Care Plan. In some instances, a request for additional funding will be made to enhance ratios and provide further support. The final decision is made by the local authority.</p>
<p>13)How are parents involved in the setting / school / college? How can I be involved?</p> <p>Describe the setting's / school's / college's approach to involving parents in decision making and day to day school life including for their own child or young person.</p>	<p>Consulting with parents in planning for each child, home visits, EHCP</p>	<p>At West Byfleet Nursery parents are involved in the setting in the following ways:</p> <ul style="list-style-type: none"> • Parents evening twice a year. • Suggestion book. • Parent access to Tapestry Online learning journey. • Regular Newsletters. • Open door policy. • Discussions with Key person/SENCO. • Planning for child's needs (SSP). • Team around the family meetings.
